1) What is Ey7 Kid?

Ey7 Kid gummies are a specially curated formulation that consist of 7 ingredients that promotes eye health by counteracting the damaging effects of blue lights emitted by various electronic devices.

2) How does Ey7 Kid work?

In this digital era as kids are exposed to many digital devices like phones, computers, laptop etc. makes one prone to the harmful effects of blue light. Each ingredient of Ey7 works by counteracting the damaging effects produced by the blue light.

Lutein and Zeaxanthin

Powerful antioxidants that defend against unstable

molecules called free radicals. Eyes are exposed to both oxygen and light, which in turn promote the production of harmful oxygen free radicals. Lutein and zeaxanthin cancel out these free radicals, so they are no longer able to damage cells of eye.

Bilberry extract

Bilberries have been observed to hold a plenitude of health-promoting properties. Research studies support their beneficial effects, among which antioxidant, vision improvement, anti-inflammatory, anti-obesity, anticarcinogenic, cardioprotective, hypoglycemic and antimicrobial.

Vitamin A (Beta-carotene)

In the retina, vitamin A in the form of retinal binds to a protein called opsin to make rhodopsin (in rod cells) and iodopsin (in cone cells). Rhodopsin and iodopsin are light-sensitive pigments. Bright light depletes rhodopsin (photobleaching). The time required to synthesize rhodopsin in the dark is called dark adaptation time and it is increased in vitamin A deficiency.

Vitamin C (Ascorbic acid)

Ascorbic acid, more commonly known as vitamin C, is a major water-soluble antioxidant in the body. It is highly concentrated in all ocular tissues, with significant levels in aqueous humor. It reacts with, and inactivates, free radicals in cytosole, plasma and extracellular fluid.

Vitamin E (DL- Alpha tocopheryl Acetate)

Vitamin E is a chain-breaking antioxidant that prevents propagation of free radical damage in cell membrane.

Zinc

Zinc is thought to play an important role in the metabolism of the retina and the lens of the eye. Zinc ions are present in the enzyme superoxide dismutase, which plays an important role in scavenging superoxide radicals.

3) Who should take Ey7 Kid?

In digital era, that too with poor eating habits one needs regular vitamin and mineral health supplement for maintenance of good eye health. While many health supplements are available for physical and mental health, there are none or few supplements available for eye health. Ey7 Kid is for children who are 5 years and above who are exposed to blue light frequently through digital devices.

4) What is Computer vision syndrome?

Computer vision syndrome also referred to as digital eyestrain, describes a group of eye and vision related problems that result from prolonged computer, tablet usage in e-readers and cell phone users etc.

5) What are the related symptoms with Computer vision syndrome

The most common symptoms associated with CVS or digital eyestrain are:

- Eyestrain.
- Headaches.
- Blurred vision.
- Dry eyes.
- Neck and shoulder pain.

6) What are the precautions to be taken while using Ey7 Kid?
